Seller understands that Vintage Guitar Gallery of Long Island will be featuring the above item to be available for sale Online as well as to local customers. Vintage Guitar Gallery of Long Island will attempt to obtain full Asking Price and will not sell the item for below the above-stated Minimum Acceptable Price without Sellers authorization by phone, email, text or any other forms of communication. Vintage Guitar Gallery of Long Island will notify the Seller with any reasonable offer. Seller is under no obligation to accept any offer below the above Minimum Acceptable Price.

If the price the Seller is asking proves too high or unreasonable due to the condition of the item, Vintage Guitar Gallery of Long Island may ask Seller permission to lower the original asking price or elect to void this agreement. If consignee elects to cancel this agreement before item(s) is sold, consignee is responsible for picking up the item within 7 days of cancellation date. A \$25/day fee will be charged for each day that surpasses the allotted 7 day pickup period described in this agreement. Seller agrees to refer all future inquiries to Vintage Guitar Gallery of Long Island. If Seller elects to have the item returned before it is sold, or cancel this agreement, Seller agrees to pay a service fee for said consigned item(s) in the amount of \$650 to cover costs of photography, marketing, and all activities conducted in preparation for sale.

Payment will be made to the Seller within two business days after buyer accepts delivery of sold item and all monies are received by Vintage Guitar Gallery of Long Island. Vintage Guitar Gallery of Long Island is selling this item on behalf of Seller and recognizes a 24 hour approval return policy for said buyer of the instrument being represented.
